

ORDINANCE 582

An ordinance calling a special election on August 8, 1967, to elect twenty-one members of a charter convention; establishing the date and place of the first meeting thereof; establishing compensation for members of said convention; establishing a date for a vote on the proposed charter; establishing polling places for said election; and declaring an emergency.

Be it ordained by the City Council of the City of Golden, Colorado:

Section. 1. There is hereby called a special election for the purpose of electing twenty-one qualified tax paying electors who have been qualified electors within the City of Golden for the past five years preceding said election, which persons shall comprise the Charter Convention of the City of Golden.

Section 2. Said special election shall be held between the hours of 7:00 A.M. and 7:00 P.M. the 8th day of August, 1967, at the usual polling places for the City of Golden

Section 3. Voting machines shall be used at said election.

Section 4. The first meeting of the said Charter Convention is hereby called for August 12th, 1967, at the hour of 10:00 A.M. in the Council Chambers at the City Hall, Golden, Colorado.

Section 5. A proposed charter prepared by said Convention shall be submitted to qualified electors of the City of Golden at the regular municipal election to be held on November 7, 1967.

Section 6. The Charter Convention members shall not receive any compensation, but shall be reimbursed upon order of Council for any expenses nec-

essarily incurred, in the convention's business.

Section 7. In the opinion of the City Council of the City of Golden, Colorado, this Ordinance is necessary for the immediate protection and preservation of the public health, safety, convenience and general welfare, and is passed and adopted for that purpose.
