

ORDINANCE NO. 820

AN ORDINANCE REAPPORTIONING AND REDISTRICTING
THE CITY OF GOLDEN, ESTABLISHING NEW WARD
BOUNDARIES, REPEALING SECTIONS OF THE GOLDEN
REVISED ORDINANCES OF 1965 IN CONFLICT THERE-
WITH, AND CLARIFYING THE APPLICABILITY THEREOF

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN,
COLORADO:

Section 1. Section 1.04.030 Golden Revised Ordinances of
1965 is here repealed and re-enacted to read as follows:

1.04.030 FIRST WARD BOUNDARY DESIGNATED

That portion of the City described as follows shall be designated as
Ward One:

Beginning at a point where the centerline of U.S. Highway 6 crosses
the north-south centerline of Section 33, T3S, R70W; thence south
and easterly along the centerline of U.S. Highway 6 to the inter-
section of 20th Street extended; thence easterly along 20th Street
extended and 20th Street to the intersection of Illinois Street;
thence southerly along Illinois Street to the intersection of 24th
Street; thence easterly along 24th Street to the intersection of
Jackson Street; thence northerly along Jackson Street to the inter-
section of 20th Street; thence easterly along 20th Street to the
intersection of Ford Street; thence southerly along Ford Street
to the intersection of 21st Street; thence easterly along 21st
Street and 21st Street extended to the existing city limits
to the northwest corner of the SW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 35, T3S, R70W, which
corner is on the north line of the Southridge Subdivision in the City
of Golden; thence easterly and southerly along the city limit line
to the intersection of South Golden Road with Ulysses Street; thence
northwesterly along the South Golden Road to the intersection of
Johnson Road; thence southerly along Johnson Road to the south line
of Section 35, T3S, R70W; thence westerly along said south line of
Section 35 to the northeast corner of Section 3, T4S, R70W; thence
southerly along the east line of said Section 3 to the centerline of
U.S. Highway 6; thence north and westerly along the centerline of
U.S. Highway 6 to the intersection of County Highway 93; thence
southerly along the centerline of County Highway 93 to the south
line of said Section 3; thence westerly along said south line of
Section 3 to the south 1/4 corner of said Section 3, which corner
is on the existing westerly city limits; thence west and northerly
along the existing westerly city limits to the point of beginning.
The first ward shall include any future extension of the city limits
westerly of the above described land.

Section 2. Section 1.04.040 Golden Revised Ordinances of 1965
is hereby repealed and re-enacted to read as follows:

1.04.040 SECOND WARD BOUNDARY DESIGNATED

That portion of the City described as follows shall be designated as

east line of said Section 3 to the centerline of U.S. Highway 6; thence north and westerly along the centerline of U.S. Highway 6 to the intersection of County Highway 93; thence southerly along the centerline of County Highway 93 to the south line of said Section 3; thence westerly along said south line of Section 3 to the south 1/4 corner of said Section 3, which corner is on the existing westerly city limits; thence southerly and westerly along the existing westerly city limits to the existing southerly city limits; thence easterly and northerly along the existing southerly city limits to the existing easterly city limits; thence westerly and northerly along the existing easterly city limits to the point of beginning. The second ward shall include any future extension of the city limits westerly, southerly, easterly or northerly of the above described land.

Section 3. Section 1.04.060 Golden Revised Ordinances of 1965 is hereby repealed and re-enacted as follows:

1.04.060 FOURTH WARD BOUNDARY DESIGNATED

That portion of the City described as follows shall be designated as Ward Four:

Beginning at a point where the north-south centerline of Section 28, T3S, R70W, crosses the centerline of Washington Avenue; thence southerly along Washington Avenue to the intersection of 6th Street; thence easterly along 6th Street and 6th Street extended to the intersection of Ford Street; thence southerly along Ford Street to the intersection of 20th Street; thence westerly along 20th Street to the intersection of Jackson Street; thence southerly along Jackson Street to the intersection of 24th Street; thence westerly along 24th Street to the intersection of Illinois Street; thence northerly along Illinois Street to the intersection of 20th Street; thence westerly along 20th Street extended to the intersection of U.S. Highway 6; thence northerly and westerly along the centerline of U.S. Highway 6 to a point on the north-south centerline of Section 33, T3S, R70W, which point is on the existing westerly city limits; thence northerly and westerly along the existing westerly city limits to the point of beginning. The fourth ward shall include any future extension of the city limits westerly of the above described land.

Section 4. The redistricting herein shall be limited in application to the general municipal election to be held November 6, 1979, and other municipal elections that occur thereafter prior to further redistricting. The redistricting herein shall have no effect on the special municipal election to be held on June 12, 1979 on the sales and use tax enactment question. Any provision of the Colorado Municipal Election Code of 1965 that may or could be construed to the contrary shall be of no force and effect, but rather, the provisions contained herein shall be controlling.

Section 5. Any ordinance or portions of ordinances in conflict herewith are hereby repealed.
