

ORDINANCE NO. 765

AN ORDINANCE VACATING A PORTION
OF 14TH STREET LOCATED WITHIN
THE CITY OF GOLDEN

WHEREAS, the vacation of 14th Street lying Westerly of Maple Street will not leave any land adjoining said portion of 14th Street without an established public road connecting said land with another established public road

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. That a portion of 14th Street located within the City of Golden and more specifically described as:

That portion of 14th Street lying between the Westerly right of way line of Maple Street and the Westerly block lines extended of Block 36 and Block 49, South Golden Addition to the City of Golden, existing after Ordinance No. 486 was adopted on September 14, 1961, vacating the adjoining portion of Elm Street,

be and hereby is vacated as a public street and thoroughfare, with an easement reserved over, across, under and upon said portion for the installation, repair and maintenance of utility lines.

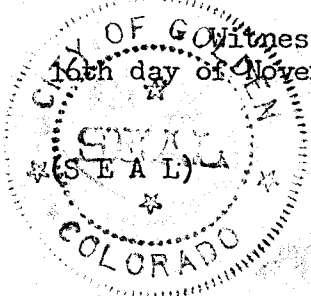
