AN ORDINANCE ADOPTING A BUDGET FOR THE FISCAL YEAR OF 1963 AND APPROPRIATING SUMS FOR DEFRAYING THE EXPENSES AND LIABILITIES FOR THE FISCAL YEAR BEGINNING JANUARY 1 1629 AND EMBING DECEMBER CAL YEAR BEGINNING JANUARY
1, 1963, AND ENDING DECEMBER
31, 1963, IN ACCORDANCE WITH
STATUTES OF THE STATE AND
ORDINANCES OF THE CITY OF
GOLDEN, AND DECLARING AN
EMERGENCY THEREFORE.
