

ORDINANCE NO. 458

AN ORDINANCE AUTHORIZING THE CONSTRUCTION AND MAINTENANCE OF COVERED WALKWAYS IN C-2 ZONED AREAS IN THE CITY OF GOLDEN, COLORADO, AND ADDING SECTION 4508 TO ORDINANCE NO. 434 OF THE CITY OF GOLDEN, COLORADO.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. There is hereby added to Ordinance No. 434, Chapter 45, Section 4508 which shall read in full as follows:

Section 4508. Covered Walkways.

A. Covered walkways shall be permitted in C-2 zoned areas in the City of Golden, Colorado, when constructed in compliance with the terms as set forth herein.

B. Covered walkways shall be constructed by and remain the property of the owner of the building to which it is attached, and maintained by said owner.

C. Covered walkways shall be covered by a wooden type, open construction built in compliance with Ordinance No. 434 of the City of Golden, Colorado, and roofed with a shake shingle type roof in compliance with said ordinance.

D. The front face of vertical supports for all covered walkways shall be set back 30 inches from the face of the abutting curb.

E. The minimum vertical clearance of any part of the covered walkway shall be not less than 8 feet, no inches, exclusive of vertical supporting columns.

F. No railings or obstructions of any other kind shall be installed between the vertical supporting columns.

G. Adequate artificial lighting shall be installed under the covered walkway so as to illuminate passageways continuously between sunset and sunrise.

H. No signs shall be attached to or supported by any part of a covered walkway.

I. Horizontal clearance between the face of the abutting curb and the roof eave line shall be 18 inches.

J. Plans and specifications for the construction of covered walkways shall be submitted to the Building Inspector for a building permit in the same manner as those for other structures in compliance with Ordinance No. 434 of the City of Golden, Colorado, and in conjunction with said application, the owner of the building to which said covered walkway is to

be attached, shall agree to relieve the City of any and all liability incurred in the construction, alteration, repair, maintenance and use of said covered walkway.

K. All portions of Chapter 45 of Ordinance 434 of the City of Golden, Colorado, in conflict herewith, shall be inoperative when applied to covered walkways built in compliance with Section 4508 of Ordinance No. 434 of the City of Golden, Colorado.

Section 2. Whereas, in the opinion of the City Council, an emergency exists, and this ordinance is necessary for the immediate preservation of the public peace, health and safety, therefore, this ordinance shall be in full force and effect upon the expiration of five days after its final passage and publication.
