ORDINANCE NO. 549

AN ORDINANCE ESTABLISHING WARD BOUNDARIES WITHIN THE CITY OF GOLDEN AND RE-PEALING ORDINANCE NO. 418.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. That the territory embraced by the limits of the City of Golden, shall be and the same is hereby divided into four wards, bounded, designated and described as hereinafter set forth.

Section 2. All that portion of said City lying South of the centerline of 13th Street and of said centerline extended Westerly, and West of the centerline of Jackson Street, and of the extension of said centerline perpendicular to 24th Street to the intersection of the Southerly line of Section 34, Township 3 South, Range 70 West; thence East along the Southerly lines of Sections 34 and 35, Township 3 South, Range 70 West to the centerline of Johnson Drive; thence Southerly along the centerline of Johnson Drive to its intersection with the South property line of the Earl Johnson School: thence East along said South property line to the North-South centerline of the NW14 of Section 2, Township 4 South, Range 70 West; thence South along said centerline and its extension South to the existing City Limit, or any future Southerly extension thereof, shall constitute one ward and shall be designated, numbered and known as the First Ward.

Section 3. All that portion of said City lying South of the centerline of 13th Street and of said centerline extended Easterly and South of the centerline of 32nd Avenue, and East of the centerline of Jackson Street and of the extension of said centerline perpendicular to 24th Street to the intersection of the Southerly line of Section 34, Township 3 South. Range 70 West; thence East along the Southerly lines of Sections 34 and 35, Township 3 South. Range 70 West, to the centerline of Johnson Drive: thence Southerly along the centerline of Johnson Drive to its intersection with the South property line of the Earl Johnson School: thence East along said South property line to the North-South centerline of the NW14 of Section 2. Township 4 South, Range 70 West thence South along said centerline and its extension South to the existing City Limit, or any future Southerly extension thereof, shall constitute one ward and shall be designated numbered and known as the Second Ward.

Section 4. All that portion of said City lying North of the centerline of 13th Street and of said centerline extended Easterly and South of the centerline of 32nd Avenue and East of the centerline of Jackson Street and of said centerline May 21, 1965.

extended Northerly to its intersection with the Northerly line of Lot 9, Block 8. Golden Park Addition extended; thence Westerly along the Northerly lines of Lots 6, 7, 8, and 9, Block 8, Golden Park Addition extended to its intersection with the centerline of Washington Avenue; thence Northerly along the centerline of Washington Avenue and the centerline of County Highway No. 93 to its intersection with the existing Northerly City Limit, or any future Northerly extension thereof, shall constitute one ward and shall be designated, numbered and known as the Third Ward.

Section 5. All that portion of said City lying North of the centerline of 13th Street and its extension Westerly and West of the centerline of Jackson Street and of said centerline extended Northerly to its intersection with the Northerly line of Lot 9. Block 8, Golden Park Addition extended; thence Westerly along the Northerly lines of Lots 6, 7, 8, and 9, Block 8, Golden Park Addition extended to its intersection with the centerline of Washington Avenue: thence Northerly along the centerline of Washington Avenue and the centerline of County Highway No. 93 to its intersection with the existing Northerly City Limit, or any future Northerly extension thereof, shall constitute one ward and shall be designated, numbered and known as the Fourth Ward.

Section 6. Ordinance No. 418 and all other ordinances and parts of ordinances in conflict herewith are hereby repealed. Adopted and approved and ordered published this 13th day of May, 1965.
