538. Section 3. The buildings within said city shall be numbered in a plain and legible manner. The City Council may provide for the expense of putting up house numbers from the general and incidental fund; and any person who shall tear down, take off, or in any manner mutilate or injure any number placed on any building within the City of Golden for the purpose of designating the number of the same, shall, on conviction thereof before any police magistrate or justice of the peace in said city, be fined in a sum not less than three nor more than twenty-five dollars. Owners of buildings may, at their own expense, number their buildings as provided by this ordinance.

## Street Names, House Numbering.

539. Section 1. That the names of the streets mentioned in this section, situate in the City of Golden, shall be, and they are hereby changed as follows: that is to say :

Junction Street is changed to First Street.
Main Street is changed to Second Street.
Park Street is changed to Third Street.
Golden Street is changed to Fourth Street.
Gregory Street is changed to Fifth Street.
Fayette Street is changed to Sixth Street.
King Street is changed to Seventh Street.
Wall Street is changed to Eighth Street.
Garrison Street is changed to Ninth Street.
Platte Street is changed to Tenth Street.
First Street is changed to Eleventh Street. Second Street is changed to Twelfth Street. Third Street is changed to Thirteenth Street.
Fourth Street is changed to Fourteenth Street.
Fifth Street is changed to Fifteenth Street.
Sixth Street is changed to Sixteenth Street.
Seventh Street is changed to Seventeenth Street.
Eighth Street is changed to Eighteenth Street.
Ninth Street is changed to Nineteenth Street.
Tenth Street is changed to Twentieth Street.
Eleventh Street is changed to Twenty-first Street.
Twelfth Street is changed to Twenty-second Street.
Thirteenth Street is changed to Twenty-third Street.
Fourteenth Street is changed to Twenty-fourth Street.
Helen Street is changed to Maple Street.
Nettie Street is changed to Elm Street.
Esther Street is changed to Birch Street.
540. Section 2. That the following mentioned rules shall be observed in numbering the buildings and lots of said city: On all streets running northeasterly and southwesterly, East street shall be considered as a base, beginning with the number 500 on each northwesterly corner of said street at its crossing with other streets. The said numbers: shall increase in reg-
ular numerical order going southwesterly, and decrease in the same manner going northeasterly. Even numbers only shall be used on the northerly side of said streets and odd numbers on the southerly side of said streets. On all streets running northwesterly and southeasterly, First street (as designated in Section 1 above), shall be considered as a base, beginning with number 100 at each southwesterly corner of said street at its crossing with other streets. Even numbers only shall be used on the westerly side of said streets.

A space of twenty-five feet shall be allowed for each number. One hundred numbers shall be allowed for each block.
541. Section 3. Section 2 of an ordinance passed by said City Council on the 12th day of October, 1881, entitled "An Ordinance Changing the Names of Certain Streets, and to Regulate the Numbering of Houses and Lots in the City of Golden," and all ordinances and parts of ordinances in conflict with this ordinance, be, and the same are hereby repealed.

## Ford Street Grade

542. Section 1. That the grade of Ford street from the bridge spanning Clear creek to the center of Fourth street be, and the same is hereby established as follows: Commencing at the south end of the bridge at an elevation of eighty-nine and seventy-one hundredths ( $8971-100$ ) feet (going upon the basis of the one hundred feet fixed at the bridge on Washington avenue) ; thence ascending two hundred and ninety-six thousandths (.296) feet per hundred to the center of Second street, at an elevation of ninetyone; thence ascending one (1) foot and three hundred and sixty-three thousandths (1.363) feet per hundred (100) feet to the center of Third street, at an elevation of ninety-six (96) feet; thence ascending two (2) feet and forty-six hundredths (2.46) feet per hundred (100) feet to center of Fourth street to an elevation of one hundred and five feet.

## ORDINANCE NO. 41

## Street Grades.

543. Section 1. That for the purpose of establishing a system of grades for the streets and alleys of the City of Golden, Colorado, to include the grades of the streets hereinafter named, and as well all other streets the grades of which shall be hereafter established, the following points in said city are hereby adopted as bench marks, described as follows, to-wit: A cross chiselled in the top face of the trimming or coping stone on the north side of steps leading to the main entrance of the county court house, said stone being that immediately above the north end of the fifth step from the bottom, and said bench mark being defined on profile of Washington Avenue, and having an elevation above the sea of 5714.033 feet; a cross chiselled on the step of door at the southwest corner of building of Colorado School of Mines situate on the southeast portion of block fifty-two on the south side of Clear creek in said city and described on the profile of Fifth street as being a cross on the step of assay room door, elevation 5730.95 feet; top of spike
