

ORDINANCE NO. 381

ORDINANCE FOR THE CREATION OF A METROPOLITAN WATER DISTRICT; DETERMINING THAT PUBLIC CONVENIENCE AND NECES- SITY REQUIRE THE ORGANIZA- TION OF A METROPOLITAN WA- TER DISTRICT; DETERMINING THAT THE CITY OF GOLDEN SHOULD BE A PART THEREOF; NAMING ORIGINATING MUNICI- PALITIES AND ESTABLISHING THE BOUNDARIES THEREOF.

THAT WHEREAS, the City of Gold- en, is desirous of joining with the here- inafter designated municipalities of the State of Colorado in organizing a Metro- politan Water District, as by law pro- vided, and

WHEREAS, a public hearing, pur- suant to notice published July 15, 22, 29, and August 5, 1955, in The Golden Outlook, a newspaper of general cir- culation in Golden, was duly held on August 11, 1955, and

WHEREAS, this City Council has de- termined that the public convenience and necessity require the organization of a Metropolitan Water District and has fully considered the existing water supply of this municipality and its ade- quacy for present and future needs of this municipality and any future addi- tions thereto,

NOW THEREFORE, BE IT OR- DAINED BY THE CITY COUNCIL OF GOLDEN, COLORADO:

1. That the public convenience and necessity require the organization of a Metropolitan Water District as pro- vided by Senate Bill No. 100, passed and adopted by the 1955 Legislature and approved by the Governor of Colo- rado April 29, 1955.

2. That the following named munici- palities be, and they hereby are, desig- nated as originating members of said Metropolitan Water District, subject to action taken by their respective gov- erning bodies after public hearing, as by law provided.

3. That the name of said Metropoli- tan Water District shall be "Tri-Count- y Metropolitan Water District", and said District shall have all the powers conferred by law.

4. That the Boundaries of said Dis- trict shall be as set forth and delin-

eated upon the map or plat attached hereto and expressly made a part here- of. Said boundaries are established for the sole purpose of determining admis- sibility of unincorporated areas as a matter of right within a period of six months from and after the effective date of organization of said District. Said boundaries shall be effective for said purpose and for said period of time and for no other purpose whatsoever.

5. That upon the effective date here- of, the City Clerk shall forthwith trans- mit a certified copy hereof to the gov- erning body of each of the originating Municipalities named herein, and a cer- tified copy hereof shall be transmitted to the Secretary of State, of the State of Colorado.

6. The City Council finds and de- termines that the passage of this or- dinance is necessary for the immediate preservation of the public health and safety and that the urgency of the or- ganization of said District for the ac- quisition of an adequate municipal wa- ter supply requires that this ordinance be in force and effect five days after final publication.
