ORDINANCE FOR THE CREATION OF A METROPOLITAN WATER DISTRICT: DETERMINING THAT PUBLIC CONVENIENCE AND NECESSITY REQUIRE THE ORGANIZATION OF A METROPOLITAN WATER DISTRICT; DETERMINING THAT THE CITY OF GOLDEN SHOULD BE A PART THEREOF; NAMING ORIGINATING MUNICIPALITIES AND ESTABLISHING THE BOUNDARIES THEREOF. THAT WHEREAS, the City of Golden, is desirous of joining with the hereinafter designated municipalities of the

inafter designated municipalities of the State of Colorado in organizing a Metropolitan Water District, as by law pro-

vided, and

WHEREAS, a public hearing, pursuant to notice published July 15, 22, 29, and August 5, 1955, in The Golden Outlook, a newspaper of general cir-culation in Golden, was duly held on

August 11, 1955, and
WHEREAS, this City Council has determined that the public convenience
and necessity require the organization of a Metropolitan Water District and has fully considered the existing water supply of this municipality and its adequacy for present and future needs of this municipality and any future additions thereto,

NOW THEREFORE BE IT OR-DAINED BY THE CITY COUNCIL OF GOLDEN, COLORADO:

1. That the public convenience and

necessity require the organization of a Metropolitan Water District as proa Metropontan water District as provided by Senate Bill No. 100, passed and adopted by the 1955 Legislature and approved by the Governor of Colorado April 29, 1955.

2. That the following named municipations of the colorado April 29, 1955.

palities be, and they hereby are, designated as originating members of said Metropolitan Water District, subject to action taken by their respective gov-erning bodies after public hearing, as by law provided.

3. That the name of said Metropolitan Water District shall be "Tri-County Metropolitan Water District", and said District shall have all the powers conferred by law.

4. That the Boundaries of said District shall be as set forth and delineated upon the map or plat attached hereto and expressly made a part here-of. Said boundaries are established for the sole purpose of determining admissibility of unincorporated areas as a matter of right within a period of six months from and after the effective date of organization of said District, Said boundaries shall be effective for said purpose and for said period of time and for no other purpose whatsoever.
5. That upon the effective date here-

of, the City Clerk shall forthwith trans-mit a certified copy hereof to the governing body of each of the originating Municipalities named herein, and a cer-tified copy hereof shall be transmitted to the Secretary of State, of the State

of Colorado.

6. The City Council finds and determines that the passage of this ordnance is necessary for the immediate preservation of the public health and safety and that the urgency of the organization of said District for the acquisition of an adequate municipal water supply requires that this ordinance be in force and effect five days after final publication.
