

ORDINANCE NO. 577

AN ORDINANCE AMENDING CHAPTER 5.16 OF THE GOLDEN REVISED ORDINANCES OF 1966, DEFINING RUBBISH, PROHIBITING ITS DEPOSIT ON PUBLIC OR PRIVATE PROPERTY, AND PRESCRIBING PENALTIES FOR THE VIOLATION OF THIS ORDINANCE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. Chapter 5.16 of the Golden Revised Ordinances of 1966 is hereby amended by the addition of the following sections:

Section 5.16.015, **Definition of Rubbish.** "Rubbish" as herein defined is any solid waste consisting of both combustible and non-combustible wastes such as paper, wrappings, cigarettes, cardboard, cans, yard clippings, leaves, wood, glass, bedding, crockery, or similar materials.

Section 5.16.025, **Rubbish on Occupied or Unoccupied Private Property.** No person shall throw or deposit rubbish on any occupied private property within the City whether owned by such person or not, except that the owner or person in control of private property may maintain private receptacles in such a manner that rubbish will be prevented from being carried or deposited by the elements upon any street, sidewalk, or other public place or upon any other private property within the City. No person shall throw or deposit rubbish on any open or vacant private property within the City whether or not owned by such person.

Section 5.16.060, **Penalties for Violation.** In addition to the assessments established herein, a violation of the provisions of this chapter shall be considered to be a misdemeanor and any person found guilty thereof may be punished in accordance with the provisions of Section 1.01.110 of this Code.
