ORDINANCE NO. 199

AN ORDINANCE AUTHORIZING BLACKOUTS AND PROVIDING FOR PROTECTION AGAINST AR PROFECTION AGAINST AIR RAIDS AND OTHER FORMS OF ATTACK.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. Blackouts and other precautionary measures.

(A) In order to protect life and property in the city of Golden, the Mayor thereof is hereby authorized empowered and directed to promulempowered and directed to promul-gate and carry out said City pre-cautionary measures against air raids and other forms of attack, such measures to include practice blackouts, racio siblackouts and blackouts, râcio silences, and such other measures as will effect the discontinuance of any activity which may assist an enemy in accomplishing his objective, and precautionary measures to minimize the loss of life or property which might result from such attacks, and precautionary measures which may be necessary for the conduct of persons during practice blackouts and blackouts, and to make, amend, or resind such general orders, rules and regulations. and to make, amend, or re-mu successions as may be Geemed necessary in connection therewith, not inconsistent with any order, rule or regulation of the Army of the United States or of the Directors of Civilian Defense.
(B) The Mayor is authorized to

delegate in writing to such agencies or persons as he may designate or appoint for such purpose the authority granted by this Or-

dinance.

(C) Without limiting the generality of the foregoing provision, the orders, rules and regulations heretofore authorized may include pro-visions for uniform air raid signals, the control of traffic movements of emergency or other vehicles, evacuation of residents, con uct of persons during practice blackouts and blackouts, lighting of streets, buildings, and vehicles, and noises of all kinds.
(D) The law-enforcing authorities

of the City are authorized and directed to enforce the orders, regulations and rules made or issued in pursuance of this Ordinance.

Section 2. Appointment of Air Raid Wardens and Others.

The Mayor, or such agencies or persons as he may designate or appoint in writing for such purpose, is hereby authorized to appoint in writing duly certified air raid wardens, fire wardens, auxiliary personnel and other civilian defense workers, and to remove them from fice for cause.

Section 3. Immunity from Liabiloffice

Neither the City of Golden nor the Mayor or the agents or representatives thereof, in good faith carrying out, complying with or attempting to comply with any or-

der, rule, or regulation promulgated pursuant to the provisions of this Ordinance, shall be liable for any injury or death to any person or persons or for the damage to any roperty as the result of any such activity. The foregoing shall not effect the right of any person to receive benefits or compensation to receive benefits or compensation to hich he might otherwise be entitled under the Workmen's Compensation Law or any rension law or under any law of the State of Colorado or any act of Congress.

Section 4. Penalties.

Any person violating this Ordinance or any of the terms and provisions thereof or any order, rule visions thereof or any order, rule or regulation promulgated in pursuance of this Ordinance, shall, upon conviction thereof, be punished by a fine not exceeding \$300.00 or by imprisonment not exceeding 90 days, or by both such fine and imprisonment imprisonment.

Section 5. Termination of Ordin-

This Ordinance shall terminate and become of no further force or effect 90 days after the final declaration of peace in the war in which the United States is now engaged, provided that it may be sooner rerealed by action of the City Council City Council.

Section 6. Effective Date of this Ordinance.

Whereas, in the opinion of the City Council, an emergency exists, and this Ordinance is necessary for the immediate preservation of the rublic peace, health and safety, therefore this Ordinance shall be in full force and effective upon the expiration of five days after its final passage and publication.
