

ORDINANCE NO. 867

AN ORDINANCE RATIFYING AND APPROVING WITHDRAWAL BY THE CITY OF GOLDEN FROM THE METROPOLITAN SEWAGE DISPOSAL DISTRICT NO. 1

WHEREAS, the City of Golden has duly requested withdrawal from the Metropolitan Sewage Disposal District No. 1 (Metro District) pursuant to Ordinance No. 862; and

WHEREAS, the Metropolitan Denver Sewage Disposal District No. 1 has approved the City of Golden's withdrawal pursuant to Resolution No. 981-6.a approved September 15, 1981; and

WHEREAS, it is the desire of the City of Golden to ratify and approve the withdrawal approval by the Metro District.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. Withdrawal by the City of Golden, Colorado from the Metropolitan Sewage Disposal District No. 1, pursuant to Metro District Resolution No. 981-6.a of September 15, 1981, contingent upon the City of Golden paying the Metro District the sum of \$440,000 to reimburse the Metro District for loss of revenues because of the exclusion, together with service charges to the date of exclusion, is hereby ratified and approved by the City of Golden.

Section 2. The Mayor is hereby authorized to execute, and the City Clerk to attest, an exclusion agreement specifying the payment of the exclusion charge of \$440,000, together with service charges to be paid the Metro District by Golden up to and including the actual date of exclusion. It is understood that the City of Golden will give the Metro District 30 days notice of the actual date of exclusion, and that the City of Golden will pay the exclusion charge of \$440,000 within 15 days from the actual date of exclusion. It is further understood that the actual amount for continuing service charges from September 15, 1981 to the date of exclusion, and the exclusion charge to be paid by the City of Golden shall be a sum of at least \$598,767, and that upon payment of the same by the City of Golden, the City of Golden will have fully satisfied all of its obligations due to the Metro District with the exception of any adjustments made on the final adjustment of the 1981 and 1982 annual charges, if any.

Section 3. Section 1 of Golden Ordinance No. 862 is hereby amended to read as follows:

Section 1. It is hereby determined by the City Council of the City of Golden that upon fully integrated treatment of Golden's sewage by the Adolph Coors Company it will no longer be feasible for the City of Golden to receive sewage service by the Metropolitan Denver Sewage Disposal District No. 1 facilities. Therefore, it is formally requested by the City Council that the City of Golden be excluded from the Metropolitan Sewage Disposal District No. 1. Said exclusion to be subject to the responsibility of Golden to timely continue to retire and
