## ORDINANCE NO. 284

AN ORDINANCE VACATING A PORTION OF VERNON STREET.
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOL-DEN, COLORADO:

Section 1. That all that portion of Vernon Street as platted on the map of Welch's Addition to the City of Golden, lying northerly of Twenty-first (21st) Street and extending to the corporate limits of the City of Colden, and lying between Blocks 6 and 7. Welch's Addition to the City of Golden, save and except that portion thereof which is now included and located within the present boundaries of Vernon Drive, is hereby vacated and abolished as a public
