

ORDINANCE NO. 515
AN ORDINANCE ANNEXING
A PORTION OF THE NW $\frac{1}{4}$
NW $\frac{1}{4}$ AND NE $\frac{1}{4}$ SW $\frac{1}{4}$ NW $\frac{1}{4}$
OF SECTION 11, TOWNSHIP
4 SOUTH, RANGE 70 WEST
OF THE 6TH P.M., COUNTY
OF JEFFERSON, STATE OF
COLORADO.
BE IT ENACTED AND OR-
DAINED BY THE CITY COUNCIL
OF THE CITY OF GOLDEN, CO-
LORADO:

Section 1. That Russell Daughen-
baugh, Albert Bachman and Kath-
erine Bachman have petitioned the
ity of Golden to annex the follow-
ing described real property into
the City of Golden, Colorado:

THE NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section
11, Township 4 South, Range
70 West of the 6th P.M., Coun-
ty of Jefferson, State of Colo-
rado, that strip along the East
conveyed to the Public Serv-
ice Company; together with
that portion of the NE $\frac{1}{4}$ SW $\frac{1}{4}$
NW $\frac{1}{4}$ of said Section 11,
which lies North of U.S. High-
way No. 40, excepting there-
from a strip along the East-
conveyed to the Public Serv-
ice Company. The described
tracts contain a total of 41.8
acres, more or less.

Said petition complies with the
pertinent laws of the State of
Colorado, and no objections have
been filed with the City Clerk-
Treasurer. Notice of the petition
has been published as required by
law. More than thirty days have
elapsed since the first publication
of the Notice. The annexation of
the above described real proper-
ty is hereby approved, and said
land shall be, and hereby is, an-
nexed to and incorporated in the
City of Golden, Colorado.

Section 2. The City Clerk-Treas-
urer is hereby directed to file with
the records of the City Clerk-
Treasurer, the records of the Clerk-
Treasurer and Recorder of Jefferson County,
Colorado, and with the office of
the Secretary of State, State of
Colorado, a copy of the plat of this
annexation, together with a copy
of this ordinance.
