ORDINANCE NO. 368

AN ORDINANCE TERMED THE AN-NUAL APPROPRIATION BILL FOR THE FISCAL YEAR ENDING DECEM-

BER 31, 1955. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

That the fiscal year ending the 31st day of December, 1955, the following sums of money, or as much thereof as may be necessary, are hereby appro-printed to defray the expenses and lia-bilities of the City of Golden, to-wit:

FIRST: \$163,054.99, to pay the Water and Sewer expenses of said City. The total sum to be spent in the following manner:

A. \$68,043.24, Water Maintenance and Production.

B. \$42,000.00, for payment of outstanding Water Bonds of said City. C. S.552.50, to pay the interest on outstanding Water Bonds of said City.

D, \$29,159.25, is hereby appropriated

for use as a Reserve for Water Con-struction or Development. E. \$19,429.12, for Sewer Mainten-

ance and Disposal. F. \$4,570.88, is hereby appropriated for use as a Reserve for Sewer Construction.

SECOND: \$111,913.21, to pay the General and Incidental expenses of said City, not otherwise provided for; the total sum to be spent in the following manner:

A. \$33,798.23, Police Department Maintenance.

B. \$30,690.48, to construct and keep in repair the streets, alleys, and bridges of said City.

C. \$7,426.38, Finance Department.

C. \$1,420,00, Final Control Control
D. \$5,883,45. City Manager.
E. \$6,416,52, Golden Cemetery.
F. \$5,111,35, Fire Department.
G. \$4,700,00, Street Lighting.

H. \$4,295 00, City Engineer.

A. \$4,255.00, City Eng. neer.
A. \$3,500.00, Parks and Recreation.
J. \$2,800.00, City Council.
K. \$1,742.40, City Attorney.
L. \$1,742.40, Police Magistrate.
M. \$1,407.00, City Hall.

N. \$1,300.00, Garbage Disposal and

Sanitation.

O. \$100.00, Planning Commission. Whereas, in the opinicn of the City Council, an emergency exists, and this ordinance is uccessary for the immediate preservation of the public peace, health, and safety, therefore, this ordinance shall be in full force and effect upon the expiration of five days after its final passage and publication.
