

ORDINANCE NO. 661

AN ORDINANCE CALLING A SPECIAL ELECTION TO
DETERMINE WHETHER THE CITY OF GOLDEN SHALL
PURCHASE LOT 9, BLOCK 4, SOUTH GOLDEN, FOR MUN-
ICIPAL PURPOSES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. At a special election held on Tuesday, June, 13, 1972, between the hours of 7:00 A.M. and 7:00 P.M., there shall be submitted to the qualified electors of the City of Golden, the following question:

"Shall the City of Golden expend the sum of \$31,480.55 from the general fund of the City of Golden to purchase from the Golden Downtown General Improvement District the following described real property, including improvements thereon:

Lot 9, Block 4, South Golden, Jefferson
County, Colorado (a/k/a 822 12th Street)?

Section 2. The official ballot after stating the above question shall provide a method of allowing the elector to express his choice as either

"FOR THE PURCHASE" or "AGAINST THE PURCHASE".

Section 3. The City Clerk is hereby directed to proceed in accordance with the law governing municipal elections in Golden, to conduct said election and to take all steps necessary toward that purpose, including the use of voting machines, if the Clerk deems this method of voting desirable.

Section 4. In the event the majority of votes cast are "For the Purchase", the City officials shall take the necessary steps to purchase said property for purposes of general municipal uses.

Section 5. In the event the majority of votes cast are "Against the Purchase", the officials of the Golden Downtown General Improvement District will remove the improvements located on the property and shall immediately make use of the property for District purposes.

Section 6. It is hereby determined by the City Council that the public good of the entire City requires that there be a special election called prior to the next regular election held in 1973.
