## CRDINANCE NO. 1029

AN ORDINANCE RELATING TO THE REZONING OF PROPERTY LOCATED IN BARBER'S THIRD ADDITION TO THE CITY OF GOLDEN, IN THE VICINITY OF STATE HIGHWAY 58 AND WASHINGTON AVENUE WITHIN THE CITY OF GOLDEN, OWNED BY EDWIN AND CAROL MORRIS, DIAMOND SHAMROCK REFINING AND MARKETING COMPANY, BILLIE AND EVERETT GROSS AND WAYNE AND MARTHA KERBAUGH, AND AMENDING THE ZONING MAPS OF THE CITY OF GOLDEN ACCORDINGLY

The zone district map areas adopted by Ordinance No. 454 of the City of Golden be and the same are hereby amended to show the property to be zoned C-1 (Limited Commercial).

Section 2. All ordinances or portions of ordinances in conflict herewith are hereby repealed.
