That portion of the lands annexed by Ordinance No. 477 lying in the SW ¼ of Section 35, Township 3 South, Range 70 West, and being North of the South Golden Road and South of the former Denver and Intermountain right of way, be and the same is hereby zoned as C-2, general commercial. mercial.

Section 3. That portion of the lands annexed by Ordinance No. 477 lying in the NW¼ or Section 2, Township 4 South, Range 70 West, and being North of the South Golden Road and West of the Westerly line of the property described in Book 1115 at page 316, of the rec-ords of Jefferson County, Colorado, be and the same is hereby zoned as

ords of Jefferson County, Colorado, be and the same is hereby zoned as C-2, general commercial.

Section 4.
