ORDINANCE NO. 895

AN ORDINANCE AMENDING THE MODEL TRAFFIC CODE AND DELETING THE REQUIREMENT FOR WRITTEN ACKNOWLEDGMENT OR PROMISE TO APPEAR UPON ISSUANCE OF A CITATION

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The Model Traffic Code adopted by reference by Section 10.04.010 of the Golden Revised Ordinances of 1965, as amended, is hereby amended by the repeal of Sections 22-9 and 22-10 thereof and re-enactment as herein provided. Section 10.04.020, of the Golden Revised Ordinances of 1965, as amended, is hereby amended by the following additions as sub-sections (C) and (D):

"10.04.020 Additions or Modifications. The Model Traffic Code, adopted by Section 10.04.010, is subject to the following additions or modifications:

(C) Section 22-9 is amended to read as follows:

Section 22-9. Notice to appear in court. Except when authorized or directed to take a person before a magistrate or other court, as provided in Section 22-5 or otherwise pursuant to State law, any police officer upon making an arrest for any violation of this Code punishable as a misdemeanor, shall take the name, address, and operator's license number of said person, the registered number of the motor vehicle involved, and such other pertinent information as may be necessary, and shall prepare and issue to him in writing on the form authorized in Section 22-2 of this ordinance a notice or summons to respond and answer to the charge against him at a place and at a time to be specified in the notice or summons, and if the arrested person does not possess a valid Colorado driver's license, such arrested person, in order to secure release, must give his written promise to appear in court by signing the penalty assessment notice or summons. If the arrested person does possess a valid Colorado driver's license, the person shall not be required to give his written acknowledgment or promise to appear, on the penalty assessment notice or summons.

(D) Section 22-10 is amended to read as follows:
