

**ORDINANCE NO. 501**

AN ORDINANCE RELATING TO CUTS OR OPENINGS IN THE PUBLIC STREETS AND ALLEYWAYS OF THE CITY OF GOLDEN, COLORADO, AND REPEALING ORDINANCE NO. 246:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. No cut or opening shall be made in any public street or alleyway of the City of Golden without first obtaining a written permit to make such cut or opening, in said Street or alleyway, from the City Engineer's Office of said City.

Section 2. A performance bond, furnished and paid for by the applicant, shall be delivered to the City Clerk of the City of Golden prior to the issuance of any street cut permit. Said bond shall be in the amount of \$1,000 and so drawn that the City of Golden may recover such costs as it may incur in any corrective work of repairing faulty street cuts and excavations; such costs shall be ascertained by the City Engineer.

Section 3. The permit required in Section 1 above shall be issued subject to the applicants compliance with "Street Cut Regulations" as promulgated by the office of the City Engineer. Said "Street Cut Regulations" shall detail the technical specifications of a street cut, establish a resurfacing fee, and provide for the inspection and acceptance of street cuts.

Section 4. Ordinance No. 246 is hereby repealed as are all other ordinances and parts of ordinances in conflict herewith.

Section 5. Whereas, in the opinion of

the City Council, an emergency exists, and this ordinance is necessary for the immediate preservation of the public peace, health and safety, therefore this ordinance shall be in full force and effect upon the expiration of five days after its final passage and publication.
