ORDINANCE NO. 740

AN ORDINANCE AMENDING RECENTLY ENACTED ORDINANCE NO. 735 DECLARING A TEMPORARY RATIONING OF GOLDEN WATER PERMITS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. Golden Ordinance No. 735 is amended by:

- A. Inserting a period after the word "consideration" on line 6 of Section 6 and striking the following phrase "and further providing the classification under consideration is not one prohibited by Section 1-B of this Ordinance".
- B. Striking Section 7 and substituting therefor the following:
 - "Section 7. Pursuant to provisions contained in the 1954 Water Supply Contract between Golden and the Pleasant View Water and Sanitation District, and faced with a water shortage, Golden hereby temporarily restricts the issuance of water permits to the District or anyone within the District to no more than 6.15 EQR units per quarter, effective retroactive to January 1, 1975. Computation of EQR units to be determined in accordance with City of Golden Ordinance No. 724. The District may allocate and prorate EQR units among and within EQR classifications and users in accordance with the provisions of this Ordinance, provided that no water permits be issued for any of the prohibited users listed in Section 1-B of this Ordinance. Potential water users from the District may apply for special dispensation pursuant to the procedures contained in Section 6 except that special dispensation may not be granted to overcome the prohibitions of Section 1.B.

Section 2. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.
