ORDINANCE NO. 971

AN ORDINANCE TRANSFERRING \$32,185.00 FROM CONTINGENCY AND APPROPRIATING \$32,185.00 FOR MISCELLANEOUS OFFICE AUTOMATION NEEDS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The City Council determines that certification by the City Manager shows there is available in the Contingency a sum in excess of \$32,185.00.

Section 2. Since the adoption of the 1984 budget, Council has determined that it is in the best interest of the City to appropriate funds for implementation of the Office Automation Plan Study. Appropriation for said study was not included in the 1984 budget.

Section 3. The cost associated with the aforementioned implementation will be paid from the OFFICE AUTOMATION PLAN IMPLEMENTATION FUND.

Section 4. The City Manager is directed to transfer from Contingency the sum of \$32,185.00 and to appropriate \$32,185.00 to the OFFICE AUTOMATION PLAN IMPLEMENTATION FUND, said transfer to occur within the budget for the calendar of 1984 and to defer expenses for the following items or equivalent
