ORDINANCE NO. 798

AN ORDINANCE APPLYING THE WATER PERMIT FEE FOR THE CITY OF GOLDEN TO PROPERTY OUTSIDE THE CORPORATE BOUNDARIES

WHEREAS, the City Council of the City of Golden by Ordinance No. 791 increased water permit fees to \$1,500.00 and it is now the desire of City Council to, in addition, apply these fees to property outside the corporate boundaries.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The first sentence of Section 13.04.040, of the Golden Revised Ordinances of 1965, as amended, is repealed and re-enacted as follows:

"A system development fee of Fifteen Hundred Dollars for each EQR (Equivalent Residential Unit) to receive water services as determined from the following schedule shall be paid by applicants prior to receiving such service, and these charges shall apply to property situated either without or within the corporate boundaries of the City of Golden."

Section 2. All ordinances or portions of ordinances in conflict herewith are hereby repealed.
