## ORDINANCE NO. 513

ORDINANCE CONCERN-ING THE RUNNING OF DOGS AT LARGE AND AMENDING SECTIONS 2. 8. AND 16 OF ORDINANCE NO. 357 OF THE CITY OF GOL-DEN, COLORADO.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. Section 2 of Ordinance No. 357 of the City of Golden. Colorado, is hereby amended to read as follows:

2. It shall be unlawful for the owner or keeper of any dog to permit the dog to run at large or to be off the premises of the said owner or keeper unless the dog is accompanied by a person and is under leash or unless the dog is within a vehicle or otherwise confined.

Section 2. Section 8 of Ordinance No. 357 of the City of Golden, Colorado, is hereby amended to read as follows:

8. Adequate provision shall be made by the City Manager for patrolling to control and enforce the provisions of this ordinance, which shall be carried out by a dog warden and the Police Department. Unlicensed dogs will be picked up by the dog warden and impounded for a period not to exceed 3 days if they are healthy, after such period if they are not claimed by the owner said dogs will be destroyed. All dogs claimed by owner will not be released until the board charge is paid and the dog or dogs duly licensed. If stray dogs are Mcensed, the owner will be notified upon impounding. The board fee for dogs maintained in the pound shall be \$1.50 per day.

Section 3. Section 16 of Ordi-

Golden, Colorado, is hereby amended to read as follows:

16. Any person or persons violating any of the provisions of this ordinance shall. upon conviction thereof, be subject to a fine of not less than \$2.00 nor more than \$100.00

Section 4. All ordinances or parts thereof of the City of Golden, Colorado, in conflict or inconsistent with this ordinance are hereby repealed. Such repeal shall not, however, be construed to revive any ordinance or parts of any ordinances heretofore repealed.

Section 5. Whereas, in the epinion of the City Council, an emergency exists, and this ordinance is necessary for the immediate preservation of the public peace, health, and safety, therefore, this ordinance hall be in full force and effect upon the expiration of 5 days after its final passage and publication.
