ORDINANCE NO. 702

AN EMERGENCY ORDINANCE TRANSFERRING \$16,219.00 FROM UNAPPROPRIATED SURPLUS, \$16,781.00 FROM THE CONTINGENCY FUND AND \$42,000.00 FROM THE REVENUE SHARING FUND, AND APPROPRIATING \$75,000.00 TO THE FIRE DEPARTMENT - ADDITION TO BUILDING ACCOUNT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The Council determines that certification by the acting City Manager shows that there is sufficient unencumbered funds of \$16,219.00 in Unappropriated Surplus, \$16,781.00 in the Contingency Fund and \$42,000.00 in the Revenue Sharing Fund, and that sufficient sums from such funds will be available to cover the transfer of sums provided for herein.

Section 2. The recent purchase of a longer aerial fire fighting truck and the increased space needs of the Golden Fire Department make expansion of the main fire station on 10th Street imperative.

Section 3. The acting City Manager is directed to transfer \$16,219.00 from Unappropriated Surplus, \$16,781.00 from the Contingency Fund and \$42,000.00 from the Revenue Sharing Fund, and to appropriate to the Fire Department - Addition to Building Account the sum of \$75,000.00, said transfer to occur within the budget for the calendar year 1973.

Section 4. Urgent Council action is necessary to appropriate sums sufficient to commence construction of the expansion of the fire station. It is imperative that construction is commenced immediately to assure completion before winter so that the soon-to-be-delivered fire truck has a station adequate to protect and preserve it from the elements and to avoid winter construction delays which will restrict the operation of the fire station and endanger the health and safety of the citizens of Golden.
