ORDINANCE NO. 1003

AN ORDINANCE AMENDING PROVISIONS OF THE METRO DISTRICT WASTEWATER PRE-TREATMENT REQUIREMENTS OF THE GOLDEN REVISED ORDINANCES OF 1965

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. Section 13.14.060 of the Golden Revised Ordinances of 1965 is hereby repealed and re-enacted as follows:

Special Pollutant Discharge "13.14.060 User shall discharge Standards. No wastewater containing any οf materials and substances in excess of the "Specific Discharge Limitations - Users" provided in the Pre-treatment/Industrial Section of the Metro Waste Control Rules and Regulations, District amended from time to time."

Section 2. Section 13.14.130 of the Golden Revised Ordinances of 1965 is hereby repealed and re-enacted as follows:

"13.14.130 Inspections and Sampling. The City may inspect the facilities of any User to ascertain whether the purpose of this Chapter is being met and all requirements are being complied with. Persons or occupants of premises where wastewater is created or discharged shall allow the City or its representatives, or representatives of the Metro District, ready access at all reasonable times to parts of the premises for all purposes of inspection, sampling, records examination or records copying in the performance of any of their duties. City, the Metro District, the Colorado Department of Health and EPA shall have the right to set up on the property such devices as are necessary to conduct sampling, inspection, compliance monitoring and/or metering operations. Where a User has security measures in force which would require proper identification and clearance before entry into his premises, the User shall make necessary arrangements with his security guards so that upon presentation of suitable identification, personnel from Metro District, the City, the

Colorado Department of Health, and EPA will be permitted to enter, without delay, for the purposes of performing their specific responsibilities."

Section 3. Any ordinances or portions of ordinances in conflict herewith are hereby repealed.
