

ORDINANCE NO. 1063

AN ORDINANCE AMENDING PORTIONS OF CHAPTER
13.08 OF THE GOLDEN REVISED ORDINANCES OF
1965 RELATING TO WATER AND SEWER RATES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN,
COLORADO:

Section 1. Section 13.08.120 of the Golden Revised
Ordinances of 1965 is hereby amended as follows:

"Section 13.08.120 Procedure upon failure to pay due charges. All rates and charges specified in Chapter 13.08 and 13.10 shall be due and payable on the first day following the end of each quarterly billing period. If such rates and charges are not paid by the last day of the month in which they become due, the city shall have the right to discontinue delivery of water and rendition of any services by the water and sewer division and whenever such delivery and services shall have been discontinued, there shall be no resumption thereof until all arrearages have been paid, including delinquent charges. Water will not be turned on in any house or private service line except upon the order of the city manager or his duly authorized agent, after the applicant has paid all arrearages and charges due, including delinquent payment charges. Water will be turned on by the water department of the city and only during regular working hours. All other persons are prohibited from turning water into any service line except on the order or permission of the city manager or his duly authorized agent. In the case where the user does not use city water and the user fails to pay the charges due, the city manager may order the sewer service line disconnected and add the cost thereof plus the reconnection cost to the arrearages.


If such rates and charges are not paid by the last day of the month in which they become due the city shall assess a delinquent charge of ten dollars (\$10.00). If such rates and charges including delinquent charges are not paid by the fifteenth day of the month following the month in which they become due, the city shall assess an additional delinquent charge of \$10.00. The fee to turn on any water service that has been disconnected due to delinquent charges shall be \$50.00. In addition, \$20.00 shall be charged a customer to test a water meter on the test bench where the meter proves accurate.

The city shall also have the right to enforce payment of any charges due it hereunder by appropriate legal action in any court, including the right to impose, file and record a lien or liens against the real property to which such water or water and services were delivered."


Section 2. Any ordinances or portions of ordinances in conflict herewith are hereby repealed.


