

**ORDINANCE NO. 532**

**AN ORDINANCE VACATING VARIOUS STREETS, ALLEYS AND EASEMENTS, LOCATED WITHIN WEST ROSEDALE SUBDIVISION AND GOLDEN HEIGHTS SUBDIVISION, COUNTY OF JEFFERSON, STATE OF COLORADO.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:**

Section 1. That Montero Street (now Orchard Street) except the East 30 feet; Maple Street (now Orion Street); Cedar Street (now Pike Street), all from the South line of Gaylord Street (now 4th Avenue) to the South line of the NW $\frac{1}{4}$  Section 12, Township 4 South, Range 70 West, and the Southerly 30 feet of Gaylord Street (now 4th Avenue) from the centerline of Cedar Street (now Ike Street) to the West line of Montero Street (now Orchard Street), and the Southerly 30 feet of Cecil Street (now Second Avenue) from the centerline of Cedar Street (now Pike Street) to the West line of the NW $\frac{1}{4}$  Section 12, Township 4 South, Range 70 West, and Cecil Street (now Second Avenue) from the centerline of Cedar Street (now Pike Street) to the West line of Montero Street (now Orchard Street), and the Northerly 30 feet of Prospect Street (Now 1st Avenue) from the West line of Montero Street (now Orchard Street) to the West line of the NW $\frac{1}{4}$  Section 12, Township 4 South, Range 70 West, and Locust Street (now Poppy Street) from the centerline of Cecil Street (now Second Avenue) to the South Line of the NW $\frac{1}{4}$  Section 12, Township 4 South, Range 70 West, and the Easterly 30 feet of Murdock Street (now Quaker Street) from the centerline of Cecil Street (now Second Avenue) to the South line of the NW $\frac{1}{4}$  Section 12, Township 4 South, Range 70 West, and

Orchard Street, except the East 30 feet and Orion Street as shown on the Golden Heights Subdivision Plat as recorded in Book 24, Page 21, of the Jefferson County Records, State of

Colorado,

be and the same are hereby vacated as public streets and thoroughfares.

Section 2. All alleys in Block 9, 10, 11, 13, 14, 15 and 16, in West Rose dale Subdivision, Jefferson County, Colorado, be and the same are hereby vacated as public alleys and thoroughfares.

Section 3. All easements in Block 5, Golden Heights Subdivision, as shown in Book 24, Page 21, of the records of Jefferson County, Colorado, be and the same are hereby vacated as public easements and thoroughfares.
