AN ORDINANCE VACATING A PORTION OF GARDEN
STREET LYING WITHIN THE CITY OF GOLDEN

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. That the following described portion of Garden Street lying within the City of Golden, County of Jefferson, State of Colorado, be and the same is hereby vacated as a public street and thoroughfare:

DESCRIPTION FOR VACATION OF PART OF GARDEN STREET

Beginning at a point which is the southwest corner of Block 4, Clark's Garden Addition to the City of Golden, thence northerly along the west line of said Block 4 to the northwest corner of Lot 10, Block 4, Clark's Garden Addition; thence westerly a distance of 22.8 feet along the northerly line extended of said Lot 10; thence southerly along a line to a point, which point is westerly a distance of 20.5 feet along the southerly line extended of Lot 2, Block 4, Clark's Garden Addition; thence easterly a distance of 20.5 feet along the southerly line extended of said Lot 2 to the point of beginning.
