

AN ORDINANCE VACATING A PORTION OF GARDEN STREET LYING WITHIN THE CITY OF GOLDEN.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. That on July 13, 1971, Ordinance No. 645 was enacted vacating a strip of Garden Street lying along the easterly side of said street in conjunction with relocation of Garden Street to the west.

Section 2. That to complete the relocation and vacation of Garden Street, it is necessary that a strip of Garden Street lying northerly of the previously vacated strip of said street, be vacated.

Section 3. That portions of Garden Street within Clark's Garden Addition to the City of Golden more fully described as:

Beginning at a point which is the Northwest corner of Lot 10, Block 4, Clark's Garden Addition to the City of Golden; thence northerly along the westerly line of said Block 4, to the Northwest corner of Lot 16, Block 4, Clark's Garden Addition; thence westerly a distance of 24.3 feet along the northerly line extended of said Lot 16; thence southerly along a line to a point, which point is westerly a distance of 22.8 feet along the northerly line extended of Lot 10, Block 4, Clark's Garden Addition; thence easterly a distance of 22.8 feet along the westerly line extended of said Lot 10 to the point of beginning.

Be and the same hereby is vacated as a public street and thoroughfare.

Section 4. There is reserved to the utility owners the continued use and the right to construct, reconstruct, operate and maintain public utilities in the vacated street.

AN ORDINANCE VACATING A PORTION OF GARDEN STREET LYING WITHIN THE CITY OF GOLDEN.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. That on July 13, 1971, Ordinance No. 645 was enacted vacating a strip of Garden Street lying along the easterly side of said street in conjunction with relocation of Garden Street to the west.

Section 2. That to complete the relocation and vacation of Garden Street, it is necessary that a strip of Garden Street lying northerly of the previously vacated strip of said street, be vacated.

Section 3. That portions of Garden Street within Clark's Garden Addition to the City of Golden more fully described as:

Beginning at a point which is the Northwest corner of Lot 10, Block 4, Clark's Garden Addition to the City of Golden; thence northerly along the westerly line of said Block 4, to the Northwest corner of Lot 16, Block 4, Clark's Garden Addition; thence westerly a distance of 24.3 feet along the northerly line extended of said Lot 16; thence southerly along a line to a point, which point is westerly a distance of 22.8 feet along the northerly line extended of Lot 10, Block 4, Clark's Garden Addition; thence easterly a distance of 22.8 feet along the westerly line extended of said Lot 10 to the point of beginning.

Be and the same hereby is vacated as a public street and thoroughfare.

Section 4. There is reserved to the utility owners the continued use and the right to construct, reconstruct, operate and maintain public utilities in the vacated street.
