

ORDINANCE NO. 680

AN ORDINANCE TRANSFERRING \$36,000.00 FROM UNAPPROPRIATED SURPLUS AND APPROPRIATING \$36,000.00 FOR CONDEMNATION OF THE SITE KNOWN AS THE POST OFFICE SITE LOCATED IN THE CITY OF GOLDEN, COLORADO, AND TRANSFERRING \$32,275.76 FROM UNAPPROPRIATED SURPLUS AND APPROPRIATING \$32,275.76 FOR PURCHASE OF THE MARSHALL PROPERTY IN THE CITY OF GOLDEN, COLORADO

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The Council determines that certification by the City Manager shows there is available a sum in excess of \$70,000.00 from unappropriated surpluses and additional revenues which exist over and above that estimated for the 1972 budget.

Section 2. Since the preparation of the budget in 1972, the City of Golden has expended or will soon expend a total of \$96,000.00 to obtain the collapsed post office site through a condemnation action and subsequently resell said site. Appropriation of an additional \$36,000.00 is necessary to supplement the original \$60,000.00 previously appropriated to meet the total anticipated \$96,000.00 obligations of the City of Golden.

Section 3. Since the preparation of the budget in 1972, the City of Golden has expended the sum of \$32,275.76 from unappropriated surplus to purchase the Marshall property from the Golden Downtown General Improvement District.

Section 4. The City Manager is directed to transfer from unappropriated surplus the sum of \$68,275.76, and to appropriate within the capital budget under an item designated "Collapsed Post Office Site Condemnation Cost", the sum of \$36,000.00, and to appropriate within the capital budget under an item designated "Purchase of Marshall Property", the sum of \$32,275.76, both transfers to occur within the budget for the calendar year 1972.
