

ORDINANCE NO. 569

AN ORDINANCE RELATING TO ZONING OF THE CITY OF GOLDEN, COLORADO, AND AMENDING THE DISTRICT MAP AS ESTABLISHED BY ORDINANCE NO. 454.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. That the following described property located in the City of Golden, County of Jefferson and State of Colorado, to-wit:

Lots 1, 2, 3, 10, 11, and 12, Block 18, North Side of Clear Creek, Golden City, Col. Terr.,

be and the same is hereby changed and rezoned from R3, General Multiple-Family to C1, Limited Commercial.

Section 2. That the following described property located in the City of Golden, County of Jefferson and State of Colorado, to-wit:

All of Block 17, North Side of Clear Creek, Golden City, Col. Terr., which lies North of the alley a portion of which has been vacated and including the vacated portion and the unvacated portion of said alley.

be and the same is hereby changed and rezoned from R3, General Multiple-Family to M2.

Section 3. That the following described property located in the City of Golden, County of Jefferson and State of Colorado, to-wit:

Lots 1, 2, 10, 11, and 12, Block 13, North Side of Clear Creek, Golden City, Col. Terr., and Lots 1 and 2, Block 12, Barber's Addition to the City of Golden.

be and the same is hereby changed and

rezoned from R2, Limited Multiple Family to RC2, General Residential Commercial.

Section 4. The District Map as adopted by Ordinance No. 454 of the City of Golden be and is hereby amended to show the aforesaid zoning changes.
