

ORDINANCE NO 418

**AN ORDINANCE ESTABLISHING
WARD BOUNDARIES WITHIN THE
CITY LIMITS OF THE CITY OF GOLD-
EN AND REPEALING ORDINANCE
NO. 51.**

**BE IT ORDAINED BY THE CITY
COUNCIL OF THE CITY OF GOLDEN,
COLORADO.**

Section 1. That the territory embraced by the limits of the City of Golden, shall be and the same is hereby divided into four wards, bounded, designated and described as hereinafter set forth.

Section 2. All that portion of said City lying South of the middle of the main channel of Clear Creek and West of the existing middle line of Washington Avenue, or any future Southerly extension thereof, shall constitute one ward and shall be designated, numbered and known as the First Ward.

Section 3. All that portion of said City lying South of the middle of the main channel of Clear Creek and East of the existing middle line of Washington Avenue, or any future Southerly extension thereof, shall constitute one ward and shall be designated, numbered and known as the Second Ward.

Section 4. All that portion of said City lying North of the middle of the main channel of Clear Creek and East of the existing middle line of Washington Avenue, or any future Northerly, extension thereof, shall constitute one ward and shall be designated, numbered and known as the Third Ward.

Section 5. All that portion of said City lying North of the middle of the main channel of Clear Creek and West of the existing middle line of Washington Avenue, or any future Northerly extension thereof, shall constitute one ward and shall be designated, numbered and known as the Fourth Ward.

Section 6. Ordinance No. 51 and all other ordinances and parts of ordinances in conflict herewith are hereby repealed.
