

ORDINANCE NO. 1042

AN ORDINANCE AMENDING THE REGULATION OF
COVERED WALKWAY SIGNAGE AND PROVIDING A
PENALTY FOR VIOLATION THEREOF

WHEREAS, the City of Golden has established regulations for the construction of covered walkways; and

WHEREAS, said regulation includes provisions for signage attached to covered walkways; and

WHEREAS, it has been determined that revision of the covered walkway signage regulation is necessary.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. Section 15.08.290 of the Golden Revised Ordinances of 1965, is hereby amended by the deletion of Subsection (H) and the renumbering of subsequent subsections as appropriate.

Section 2. Section 18.32.045 of the Golden Revised Ordinances of 1965, is hereby adopted, as follows:

18.32.045 Covered Walkway Signage. The following sign regulations shall pertain to permissive signs which may be mounted below a covered walkway as allowed by Chapter 15.08.290 and are supported by said covered walkway. Projecting signs, wall mounted, shall not be allowed below any such covered walkway.

1. Clearance above sidewalk: A covered walkway sign shall have not less than seven feet six inches nor more than nine feet clearance above the sidewalk.

2. Clearance from building front wall: A covered walkway hung sign shall have its inboard edge not less than eleven inches nor more than thirteen inches from the building front wall.

3. Length of sign: A covered walkway hung sign shall have a length of not less than forty inches nor more than forty-eight inches.

4. Height of sign: A covered walkway hung sign shall have a height of not less than four inches nor more than twelve inches.

5. Thickness of sign: A covered walkway hung sign shall have a thickness not to exceed two and one half inches.

6. Lighting of sign: Covered walkway signs shall not be internally illuminated nor have attached lighting components. Indirect illumination shall be permissible provided such lighting is in a manner as to shield the street from lighting glare.

7. Number of signs: For single tenant occupancy, one sign shall be permitted for each building entrance located within the limits of the covered walkway. For multiple tenant occupancy, one sign shall be permitted for each tenant regardless of the number of building entrances.

8. Text on sign: The following information may be placed on a covered walkway sign:

(a) Name of store or business.

(b) Identification of store or business by product and/or service (trade names or brands shall not be used).

(c) Identification or association symbols.

9. Sign permit: A sign permit shall be procured from the City of Golden prior to the hanging of a covered walkway sign.

10. No sign other than that referred to above shall be attached to or supported by any part of a covered walkway.

11. Covered walkway hung signs existing as of the date of this amendment, except those which fail to meet the minimum clearance above the

sidewalk, will be considered to be "grandfathered" and allowed to remain. All new or replacement walkway hung signs shall fully conform to the provisions of this section.

Section 3. The penalty for violation of this ordinance shall be as prescribed by Section 1.01.110 of the Golden Revised Ordinances.

Section 4. All ordinances or portions of ordinances in conflict herewith are hereby repealed.
