ORDINANCE No. 555

AN ORDINANCE RELATING TO ZONING OF THE CITY OF GOLDEN, COLORADO, AND AMENDING THE DISTRICT MAP AS ESTABLISHED BY ORDINANCE NO. 454.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN. COLORADO:

Section 1. That the following described property located in the City of Golden, County of Jefferson and State of Colorado, to-wit:

That portion of Block 85, Kinney's Addition to the City of Golden, and Block 85, Welch's Addition to the City of Golden, described as follows: Beginning at the South-westerly corner of Lot 12, Block 85, Welch's Addition to the City of Golden: thence Northerly along the Easterly line of Washington Avenue, 140.0 feet to the Northwesterly corner of Lot 7, Block 85, Kinney's Addition to the City of Golden; thence Northeasterly parallel with the Northerly line of 18th Street, 150.0 feet; thence Southeasterly parallel with the Easterly line of Washington Avenue, 140.0 feet to a roint on the Northerly line of 18th Street; thence Southwesterly along the Northerly line of 18th Street, 150.0 feet to the point of beginning.

Section 2. All Ordinances or parts of Ordinances in conflict herewith are here-

Section 3. Whereas, in the opinion of the City Council, an emergency exists in that immediate office facilities are needed in order to retain a large employer in the City, and this Ordinance is necessary for the immediate preservation of the public peace, health and safety, therefore, this Ordinance shall be in full force and effect upon the expiration of five days after its final passage and publication.
