AN ORDINANCE RELATING TO THE REZONING OF 3.8 ACRES OF PROPERTY, LOCATED AT 1306-8TH STREET, NOW OWNED BY SAIL-A-WAY, INC., AND AMENDING THE ZONING MAPS OF THE CITY OF GOLDEN ACCORDINGLY

WHEREAS, Jerry L. Mason on behalf of Sail-a-Way, Inc., has made application to the City of Golden for rezoning of the hereinafter described property from C-1 (Commercial 1) to R-3 (Multiple units) to permit the development of condominium use; and
