## ORDINANCE NO. 625

AN ORDINANCE ANNEXING A TRACT OF LAND LOCATED IN A PART OF SECTION 15, TOWNSHIP 4 SOUTH, RANGE 70 WEST OF THE 6TH PRINCIPAL MERIDIAN TO THE CITY OF GOLDEN

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The following described property is hereby annexed to the City of Golden in accordance with "The Municipal Annexation Act of 1965":

That part of Section 15, Township 4 South, Range 70 West of the 6th P.M. more particularly described as follows:

Beginning at the Northwest corner of said Section 15, thence S 88°55' E, along the North line of said Section 15; a distance of 4474.5 feet to the NW corner of the E 1/2 E 1/2 NE 1/4 of said Section 15; thence Southerly along the Westerly right of way line of U.S. Highway 40 a distance of 4538 feet, more or less; thence N 2°39.5' W, a distance of 1544 feet, more or less, to a point on the East-West centerline of said Section 15, which point is 1029.2 feet West of the E 1/4 corner of said Section 15; thence N 88°56'30" W along the East-West centerline of said Section 15 a distance of 4068.5 feet to the W 1/4 corner of said Section 15, thence N 0°15'30" W along the West line of said Section 15, a distance of 2646.3 feet to the point of beginning; containing 284.08 acres, more or less.

Section 2. The owners of 100% of the property described above exclusive of streets (highway right-of-way) and alleys have petitioned the City Council of the City of Golden for annexation to the City of Golden.
