AN ORDINANCE RELATING TO
THE WATER WORKS OF THE CITY
OF GOLDEN AND ESTABLISHING
FEES AND CHARGES FOR CONNECTIONS AND TAPS MADE ON SAID
WATER WORKS AND ESTABLISHING WATER WORKS AND ESTABLISHING FEES AND CHARGES FOR INSTALLATION OF WATER METERS.
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN,

COLORADO: Section 1. There is hereby established the following schedule of fees and charges for individual tapping or con-

necting into or with the water system of the City of Golden, to-wit: a. For individual taps or connections made within the limits of the City:

1. Three-quarter (%) inch

Three-quarter (%) inch tap. \$150.00 Dollars. 2. One (1) inch tap, \$200.00 Dol-

3. One and one-half (11/2) inch tap,

\$275.00 Dollars. 4. Two (2) inch tap or connection, \$350.00 Dollars.

5. Three (3) inch tap or connection, \$450.00 Dollars.

Four (4) inch tap or connection, \$600.00 Dollars.

7. Taps or connections in excess of

4 inches, \$1,000.00 Dollars. b. For individual taps or connections made beyond the corporate limits of the City:

Three-quarter (34) inch tap, \$350.00 Dollars.

2. One (1) inch tap, \$400.00 Dollars.

3. One and one-half (11/2) inch tap, \$475.00 Dollars.

4. Two (2) inch tap or connection,

\$550.00 Dollars.

5. Three (3) inch tap or connection, \$650.00 Dollars.
6. Four (4) inch tap or connection, \$800.00 Dollars.

7. Taps or connections in excess of inches, \$1,200.00 Dollars.
Section 2. There is hereby established the following schedule of fees and charges for the installation of water meters:

The City shall hereafter install water meters for individual users with-in such users service lines and shall charge therefor, the actual cost to the City of such installation. For the purpose of computing said cost, the net cost of the meter, yoke or shutoff, meter pit or tile and meter lid, shall be computed and the applicant for such meter shall be charged that amount. The City shall not include any labor costs or charges in com-puting said installation charge. Said meter, shall upon installation thereof

become and remain the property of the City and said City shall thereafter properly maintain and keep said meter in good repair and operating condition.

Section 3. From and after the adoption of this Ordinance said City shall make and install all taps or connections into and with its said water system or works or lines appurtant thereto in accordance with the foregoing schedules of fees and charges, and all taps or connections shall be made by the City or its authorized agent.

Section 4. The provisions of this ordinance shall not apply or relate to the supplying of water, rendition of services or installations of connections to or upon any water supply system owned, operated or controlled by any duly organized and legally existing Wa-

r or Water and Sanitation District. And Whereas, in the opinion of the City Council, an emergency exists, and this ordinance is necessary for the immediate preservation of the public peace, health, and safety, therefore, this ord-inance shall be in full force and effect upon the expiration of five (5) days after its final passage and publication.
