ORDINANCE NO. 1030

AN ORDINANCE RESTRICTING THE GROSS WEIGHT OF CERTAIN VEHICLES TRAVELING ON PORTIONS OF JEFFERSON COUNTY HIGHWAY 93 WITHIN THE CITY OF GOLDEN; AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. The Golden Revised Ordinances of 1965, as amended, are hereby amended by the addition of Section 10.76.230, as follows:

- 10.76.230 Vehicles exceeding 10,000 lbs. gross weight prohibited from using portions of Highway 93.
- (a) No person shall operate or drive a vehicle upon or over that portion of Jefferson County Highway 93 located from the intersection of U.S. Highway 6 and Jefferson County Highway 93 southerly to the intersection of U.S. Highway 40 and Jefferson County Highway 93, within the corporate limits of the City of Golden, which has more than a 10,000 lb. gross weight. The traffic engineer shall erect or cause to be erected and maintained signs designating the within prohibitions.
- (b) The terms and provisions of this Section shall not apply to any vehicle which is traveling on the aforementioned portion of Jefferson County Highway 93 to make a local delivery to a home, residence or business within the immediate neighborhood or to any vehicle owned by a resident of the immediate neighborhood, nor to a school or RTD bus, nor to an authorized emergency vehicle.

Section 2. Penalty. Every person convicted of a violation of the provisions of this ordinance shall be punished according to the penalties prescribed in Section 1.01.110 of the Golden Revised Ordinances of 1965.

Section 3. Any ordinance or portions of any ordinance in conflict herewith are hereby repealed.
