(1) Schedule of permit fees for permits required under Sections 301, 302 and 303 shall be made at the time of filing application in accordance with the following schedule: schedule:

(2) Buildings — For a permit to erect a building the fee shall to erect a building the fee shall be at the rate of two dollars and fifty cents (\$2.50) per one thousand dollars (\$1,000) valuation; such valuation to be determined by the Building Inspector in accordance with a valuation schedulars adopted by the City Council. Section 6. That Section 311 (I) of the "Building Code for Colorado Cities and Towns" be amended with a sub-section (h) to read as follows:

(h) New residential Units—
where a building permit has been
issued for a residential structure
of four (4) dwelling units or less
such building valuation shall include the costs of mechanical services (heating, plumbing, and
electrical systems) and no separate permits for such mechanical
services shall be required.
