ORDINANCE NO. 528

AN ORDINANCE ANNEXING PORTIONS OF THE NW¼ OF SECTION 12, TOWNSHIP 4 SOUTH, RANGE 70 WEST OF THE 6TH P. M., COUNTY OF JEFFERSON, STATE OF COLO-RADO

BE IT ENACTED AND ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN. COLORADO:

Section 1. That Arnold L. Condron, Barbara J. Condron, Minnie H. Lowery, George F. Bruhn, Gerald C. Woodruff, Ethel M. Woodruff, Wallace M. Carter, Alice W. Carter, Lloyd L. Acree, Betty Jean Acree, and Foothill Industries have petitioned the City of Golden, State of Colorado, to annex the following described tracts of real property anto the City of Golden, Colorado:

A portion of the NE 14 NW 14 NW 14 of Section 12, Township 4 South, Range 70 West of the 6th P. M., County of Jefferson, State of Colorado, more particularly described as follows: Beginning at the Northeast corner of the NW 1/4 NW 1/4 of said Section 12: thence Southerly along the East line of said NW14 NW 4 of Section 12, a distance of 250.0 feet to the point of true beginning: thence Southerly along the East line of said NW14NW14 of Section 12; a distance of 410 feet, more or less, to the South line of the NE4 NW 14 NW 14 of said Section 12: thence Westerly along the South line of said NE 4NW 4N-W 1/4 of Section 12 a distance of 528 feet; thence North and parallel to the West line of Section 12, a distance of 420 feet to the Southerly right of way line of U.S. Highway 6: thence Easterly along the Southerly right of way line of U. S. Highway 6 and parallel to the North line of said Section 12 a distance of 396.0 feet: thence Southerly and parallel to the West line of Section 12 a distance of 10 feet: thence Fasterly along the Southerly right of way of U. S. Highway 6 and parallel to the North line of said Section 12 a distance of 132 feet to the true point of heginning; containing 5.06 acres, more or less,

A portion of the W16NW14 of Section 12. Townshin 4 South, Range 70 West of the 6th P. M., County of Jefferson. State of Colorado, more particularly described as follows: Beginning at the Northwest corner of the SW14NW14 of said Section 12: thence Northerly along the West line of said Section 12 to the North line of SW 4NW 4N-W 1/4 of said Section 12; thence Easterly along the North line of said SW 1/4 NW 1/4 NW 1/4 of said Section 12 to the Northeast corner of the W1/2SW1/4NW1/4NW1/4 of said Section 12, which corner is the Northwest corner of Lot 14 of the Foothills Industries Subdivision as recorded the Town Plats of Jefferson County, Colorado, on Page 5 of Book 22; thence Southerly along the West line of said Lot 14 a distance of 354.72 feet; thence East-erly along the South line of said Lot 14 a distance of 165.13 feet; thence Northerly along the East line of said Lot 14 a distance of 124.88 feet; thence Easterly along the

South line of 5th Avenue as shown on said Foothill Industries Subdivision plat a distance of 165.17 feet to the center line of Pike Street as shown on said plat; thence South along the center line of said Pike Street a distance of 418.01 feet to the South line of the NW 14 NW 14 of said Section 12; thence Easterly along the South line of said NW NW 14 of said Section 12 to the Northeast corner of the W 1/2 NE 1/4 SW 1/4 NW 1/4 of said Section 12; thence Southerly along the East line of the W 1/2 E 1/2 SW 1/4-NW14 of said Section 12 to the South line of the NW14 of said Section 12: thence West along the said South line of the NW14 of said Section 12 to the West line of said Section 12: thence North along the said West line of Section 12 to the point of beginning; containing 37.78 acres, more or less.

Said petition complies with the pertinent laws of the State of Colorado, and no objections have been filed with the City Clerk-Treasurer. Notice of the petition has been published as required by law. More than thirty days have elapsed since the first publication of the notice. The annexation of the above-described real property is hereby approved, and the said land shall be, and hereby is, annexed to and incorporated in the City of Golden Colorado.

Section 2. The City Clerk-Treasurer is hereby directed to file one copy of a map showing the ahove-described property with the Clerk and Recorder of Jefferson County, Colorado, and to retain in his files another copy of said map together with a photostatic copy of the petition requesting annexation. In addition, the City Clerk-Treasurer is directed to file a copy of said map, together with a copy of the ordinance approving annexation with the Secretary of State of the State of Colorado.
