

**ORDINANCE NO. 415**

AN ORDINANCE ANNEXING CERTAIN LANDS IN THE SOUTHWEST ONE-QUARTER OF THE SOUTHWEST ONE-QUARTER OF THE SOUTHEAST ONE-QUARTER OF SECTION 21, TOWNSHIP 3 SOUTH, RANGE 70 WEST OF THE 6TH PRIME MERIDIAN, COUNTY OF JEFFERSON, STATE OF COLORADO, MORE PARTICULARLY DESCRIBED IN THE TEXT OF THE ORDINANCE APPROVING THE PLAT OF SAID LANDS AS FOSS'S ADDITION TO THE CITY OF GOLDEN, COLORADO.

BE IT ENACTED AND ORDAINED BY THE CITY COUNCIL, CITY OF GOLDEN, COLORADO THAT:

Section 1. F. A. Foss and Barbara F. Foss have petitioned the City of Golden to annex the following described real property to the City of Golden:

A portion of the SW  $\frac{1}{4}$  SW  $\frac{1}{4}$  SE  $\frac{1}{4}$  of Section 21, Township 3 South, Range 70 West of the 6th P. M., County of Jefferson, State of Colorado, more particularly described as beginning at the South quarter corner of said Section 21; thence North 1°01'30" West along the west line of said SE  $\frac{1}{4}$  130.00 feet to a point; thence North 87° 51' East 170.00 feet to a point; thence South 1°01'30" East 130.00 feet to a point on the south line of said SE  $\frac{1}{4}$ , which line is the present City Limits Line of the City of Golden; thence South 87°51' West along the said line 170.00 feet to the point of beginning.

Said petition complies with the pertinent laws of the State of Colorado. No objections have been filed with the City Clerk-Treasurer. Notice of the petition has been published as required by law. More than thirty days have elapsed since the first publication of said notice. The annexation of the above described real property is hereby approved, and

said land shall be and hereby is, annexed and incorporated in the City of Golden.

Section 2. F. A. Foss and Barbara F. Foss have caused to be platted the real property described in Section 1 hereof under the name of Foss's Addition. The City Clerk-Treasurer is hereby directed to file with the Records of the Clerk and Recorder of Jefferson County, Colorado, and with the Office of the Secretary of State, State of Colorado, a copy of the plat of Foss's Addition together with a copy of this Ordinance.
