

ORDINANCE NO. 933

AN ORDINANCE TRANSFERRING \$1,000 FROM
CONTINGENCY AND APPROPRIATING
TO THE MUNICIPAL COURT - COURT OF RECORD
FUND

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN,
COLORADO:

Section 1. The City Council determines that certification
by the City Manager shows there is available in Contingency a sum in
excess of \$

Section 2. Since the adoption of the 1983 budget, Council
has determined that it is in the best interest of the City to provide
funds for a court of record for Municipal Court. An appropriation
for said appraisal was not included in the 1983 budget.

Section 3. The cost associated with the aforementioned
appraisal will be paid from the Municipal Court - Court of Record
Fund.

Section 4. The City Manager is directed to transfer from
Contingency the sum of \$1,000 and to appropriate \$1,000 to the
Municipal Court - Court of Record Fund, said transfer to occur
within the budget for the calendar year of 1983.
