

ORDINANCE NO. 793

AN ORDINANCE AUTHORIZING THE EXECUTION OF  
AN AGREEMENT FOR SALE OF CERTAIN WATER  
FACILITIES AND ACQUISITION OF CERTAIN WATER  
RIGHTS BY THE CITY OF GOLDEN

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN,  
COLORADO:

Section 1. That the City of Golden enter into an Agreement for the sale of their interest in certain water facilities and the purchase of certain water rights with AMAX, Inc., a New York corporation.

Section 2. The Agreement to be executed by the City of Golden and AMAX, Inc., shall be as provided in Exhibit "A" hereto, the Agreement of the respective parties dated April 4, 1978, attached hereto and incorporated herein by this reference.

Section 3. The Mayor of the City of Golden is hereby authorized and directed to execute said Agreement and the City Clerk of the City of Golden is hereby directed and authorized to attest said execution.

Section 4. Emergency. Said Agreement and the fulfillment of the terms and conditions contained therein are necessary to protect the health and welfare of the citizens of Golden, Colorado, by providing additional water rights for said city and its inhabitants, and the City Council hereby finds, determines, and declares that this ordinance is necessary for the immediate preservation of the public peace, health and safety of the citizens of the City of Golden.

Introduced, read and approved on first reading at a special meeting of City Council on the 3rd day of April, 1978.

Adopted unanimously on second reading at a special meeting of City Council on this 4th day of April, 1978, and ordered published within ten days hereafter in the Golden Outlook, a newspaper of general circulation within the City of Golden.

AN ORDINANCE AMENDING ORDINANCE NO. 784,

Section 1. Ordinance No. 784, of the City of Golden, Colorado, is hereby repealed and re-enacted as follows:

"Section 1. That a portion of Maple Street located within the City of Golden and more specifically described as

That unvacated portion of Maple Street lying between Block 101 and Block 102, South Golden, City of Golden, County of Jefferson, State of Colorado

be and the same is hereby vacated as a public street and thoroughfare".
