

**ORDINANCE NO. 361**

AN ORDINANCE TERMED THE ANNUAL APPROPRIATION BILL FOR THE FISCAL YEAR ENDING DECEMBER 31, 1954, AND REPEALING ORDINANCE NO. 352.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

That the fiscal year ending the 31st day of December, A. D., 1954, the following sums of money, or as much thereof as may be necessary, are hereby appropriated to defray the expenses and liabilities of the City of Golden, to-wit:

First: \$145,168.59, To pay the Water and Sewer expenses of said City. The total sum to be spent in the following manner:

- A. \$58,714.96, Water Maintenance and Production.
- B. \$42,930.09, For payment of outstanding Water Bonds of said City.
- C. \$3,375.60, To pay the interest on the outstanding Water Bonds of said City.
- D. 5,220.04, Is hereby appropriated for use as a Reserve for Water Construction.
- E. \$20,319.42, Sewer Maintenance and Disposal.
- F. \$2,328.02, Is hereby appropriated for use as a Reserve for Sewer Construction.

Second: \$106,412.06, To pay the General and Incidental expenses of said City, not otherwise provided for:

- A. \$28,194.87, To construct and keep in repair the streets, alleys, and bridges, of said City, together with culverts, sidewalks, and crosswalks.
- B. \$32,197.23, Police Department Maintenance.
- C. \$1,396.16, Golden Cemetery.
- D. \$6,484.74, Finance Department.
- E. \$6,824.69, City Manager.
- F. \$4,677.00, Fire Department.
- G. \$4,066.22, City Engineer.
- H. \$4,100.28, Street Lighting.
- I. \$2,450.00, Parks and Recreation.
- J. \$2,630.00, City Council.
- K. \$1,732.68, City Attorney.
- L. 1,707.68, Police Magistrate.
- M. \$1,656.20, City Hall.
- N. \$1,200.00, Garbage Disposal.
- O. \$100.00, Planning Commission.

Whereas, in the opinion of the City Council, an emergency exists, and this ordinance is necessary for the immediate preservation of the public peace, health, and safety, therefore, this ordinance shall be in full force and effect upon the expiration of five (5) days after its final passage and publication.
