# A RESOLUTION OF THE GOLDEN CITY COUNCIL REVISING THE FEES AND CHARGES FOR THE GOLDEN CITY CEMETERY PREVIOUSLY ADOPTED BY RESOLUTION NO. 1065

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

<u>Section 1.</u> Schedule of Charges. The fees and charges for cemetery grave spaces and services at the Golden City Cemetery, which shall be paid in full prior to use of the spaces or services, are as follows:

Section 3. No cremains shall be allowed above an infant burial in the infant section of the cemetery.
