RESOLUTION NO. 1354

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GOLDEN SETTING FORTH A STATEMENT OF COMPLIANCE WITH HB 01S2-1006 CONCERNING RECREATION AND TOURISM ELEMENTS OF THE CITY'S MASTER PLAN

WHEREAS, in the Second Extraordinary Session of 2001, the Colorado General Assembly passed HB 01S2-1006, requiring certain municipalities, including the City of Golden, to adopt master plans, also known as comprehensive plans, for the development of their communities; and

WHEREAS, HB 01S2-1006 also requires that each such plan contain a "recreation and tourism element," pursuant to which the municipality "shall indicate how it intends to provide for the recreational and tourism needs of residents of the municipality and visitors to the municipality through delineated areas dedicated to, without limitation, hiking, mountain biking, rock climbing, skiing, cross country skiing, rafting, fishing, boating, hunting, and shooting or any other form of sports or other recreational activity, as applicable, and commercial facilities supporting such uses"; and

WHEREAS, through passage of Resolution No. 498 on August 12, 1993, City Council approved a master plan (comprehensive plan) ("Plan") for the City; and

WHEREAS, the Plan addresses the recreation and tourism requirements of HB01S2-1006 as follows:

- 1. Policy 2.3.3 states: "Unique and irreplaceable natural, scenic, and cultural resources will be preserved for the enjoyment of future citizens and visitors. An extensive park, trail, and open space network will be created for the enjoyment of tourists, employees, and residents of Golden."
- 2. Policy 2.3.4 states: "Because of citizen support, the City will be able to provide high quality public, human, and recreational services to its citizens."
- 3. Policy 3.3.3 states: "The City should continue to encourage visitor related improvements and economic development efforts that can take advantage of the unique character/uses of Golden and surrounding areas, especially the downtown core."
- 4. Policy 3.8.1 states: "The City should ensure that park and recreation facilities are integrated and linked to neighborhoods and activity centers through a system of trails, bikeways, and open space corridors."
- 5. Policy 3.8.2 states: "The City should periodically update its standards and priorities for parks and recreation facility land acquisition, development, and maintenance."
- 6. Policy 3.8.3 states: "The City should monitor and update user needs for parks and recreation facilities."
- 7. Policy 3.8.5 states: "The City should develop partnerships with agencies, private sector providers, the school district, and businesses to facilitate cost effective facility development and delivery of recreation services."
 - 8. Policy 3.8.6 states: "The City should foster pride and support of park facilities by encouraging

public awareness programs and by actively involving neighborhood groups and users in the planning and management of park and recreation facilities."

- 9. Policy 3.8.7 states: "The City should commit to incorporating the arts into the planning and development of park and recreational facilities."
- 10. Policy 3.9.1 states: "The City should develop a multipurpose trail and greenway system to link parks, open spaces, recreation facilities, compatible land uses, and activity centers, within and outside of Golden."
- 11. Policy 3.9.4 states: "The City should try to locate trails and greenways along railroad, utility, and drainage corridors and right-of-ways."
 - 12. Policy 4.5.3 states:
- "Create a regional network of trails linking large open space parks."
- "Provide active community and neighborhood parks in growth areas based upon population, in the amount required in the Parks Master Plan."
- "Link park and community facilities to major residential and employment areas."
- "Public projects will typically include a percentage of the total project cost for the arts."

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

The City of Golden finds and declares that it is in compliance with the requirements of HB 01S2-1006 requiring a recreation and tourism element in its master or comprehensive plan.
