

**RESOLUTION NO. 1445**

**A RESOLUTION OF THE GOLDEN CITY COUNCIL  
REVISING THE FEES AND CHARGES FOR THE  
GOLDEN CITY CEMETERY PREVIOUSLY  
ADOPTED BY RESOLUTION NO. 1326**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:

Section 1. Schedule of Charges. The fees and charges for cemetery grave spaces and services at the Golden City Cemetery, which shall be paid in full prior to use of the spaces or services, are as follows:

Section 2. The number of cremains are limited to two per burial plot or one interment with one cremains above such interment.


Section 3. No cremains shall be allowed above an infant burial in the infant section of the cemetery.

Section 4. In addition to the fees specified above, the fees for setting headstone foundations are as follows:

Section 5. These fees and charges shall be effective January 1, 2004.




