

RESOLUTION NO. 1248

**A RESOLUTION OF THE CITY OF GOLDEN ESTABLISHING
REVISED FEES FOR THE COMMUNITY CENTER 2002**

WHEREAS, the Parks and Recreation staff has conducted a survey of the fees of comparable facilities in the metropolitan area; and

WHEREAS, fee increase recommendations were made to the Parks and Recreation Advisory Board; and

WHEREAS, the City Council has determined that the fee increases as recommended to them by the Parks and Recreation Advisory Board are necessary to reflect the increased costs of providing such services and to be comparable with the metro area.

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GOLDEN, COLORADO:



Section 3. Fees for the Tony Grampsus Memorial Park formerly known as Table Mountain Sports Complex shall remain as established by Resolution No. 1066.


Section 4. These fees and charges shall be effective January 1, 2002.




