RESOLUTION NO. 1259

A RESOLUTION AMENDING THE DATE OF HEARING AS SET BY RESOLUTION 1246 REGARDING THE ELIGIBILITY FOR ANNEXATION FOR A CERTAIN PARCEL OF LAND IN THE NORTHEAST QUARTER OF SECTION 11, TOWNSHIP 4 SOUTH, RANGE 70 WEST AS PETITIONED BY THE COLORADO DEPARTMENT OF TRANSPORTATION

The hearing for eligibility for annexation of a certain parcel of land located in Section 11, Township 4 South, Range 70 West of the 6th P.M., more particularly described in Exhibit A, attached hereto and incorporated herein by this reference, is hereby rescheduled for January 24, 2002 at 7:30 p.m. in the City Council Chambers, Golden City Hall, 911 10th Street, Golden, Colorado, to determine if the proposed annexation complies with Sections 31-12-104 and 31-12-105, Colorado Revised Statutes, or such parts thereof as may be required to establish eligibility for annexation.

EXHIBIT A

LEGAL DESCRIPTION - Marine Memorial Annexation

A portion of the right-of-way of U.S. Highways 6 (a.k.a. West 6th Avenue) and 40 (a.k.a. West Colfax Avenue) located in the North half of Section 11, Township 4 South, Range 70 West of the 6th Principal Meridian, Jefferson County, Colorado being described as follows:

BEGINNING at the Northeast corner of the Annexation to the City of Golden described in Ordinance No. 465, described as being at the intersection of the North-South centerline of said Section 11 with the South line of U.S. Highway No. 6, which point lies South 00°15'00"East, 250 feet along said centerline from the North quarter corner of said Section 11; thence departing said North-South centerline, North 86°49'28"East, 944.12 feet, more or less, to the intersection with the Northeasterly projection of the South lines of the Highway right-of-way parcels described in the deeds recorded in Book 536 at Page 114 and in Book 543 at Page 403; thence along said projected line and the South lines of said parcels, South 60°13'00"West, 1083.70 feet, more or less, to said North-South centerline and the Southeast corner of said Annexation described in Ordinance No. 465; thence along said North-South centerline, North 00°15'00"West, 486 feet, more or less, to the POINT OF BEGINNING of this description, containing 5.26 acres, more or less.
